# 4.1 VETERAN CAR CLUB FREE USE OF CLOAK OVAL - FUND RAISER ANNUAL CAR SHOW:

## **Background:**

The Veteran Car Club has been holding an annual car show raising funds for various charities at Cloak Oval, Old Beach for several years now. These shows have been successful and are patronised well by locals and people from out of the area.

The Car Club has received, up to date, a 50% discount on the hire fee as they have been raising funds for charities. They have now asked Council to consider waiving all fees on an annual basis to allow more funds to be allocated to these charities.

# 4.2 YOUTH MOVING FORWARD GROUP - FREE USE OF BRIGHTON CIVIC CENTRE MEETING ROOM:

## **Background:**

The Brighton Youth Moving Forward group have written to Council requesting free use of the meeting room for their fortnightly meetings. The purpose of these meetings is to develop their strategy to improve youth support services in the municipality.

# **Risk Implications:**

May set a precedent for other community groups to seek free Council of Council facilities.

# **Financial Implications:**

The cost of this donation of the free use of the room would be \$50.00/hr for the 2018/19 financial year ie \$450 (6 meetings @ 1.5/hrs). It is expected their meeting would run for approximately 1.5 hrs each fortnight.

#### **Assessment:**

The Youth Moving Forward Group has been meeting regularly to undertake strategic and organisational planning to improve support services for the youth of the Brighton municipality. The group comprises local residents and external stakeholders who are volunteering their time to develop a sustainable youth centre and ancillary support services.

# **Options:**

- 1. As per the recommendation.
- 2. Council not approve free use of Civic Centre meeting rooms.

#### RECOMMENDATION:

Council waive the hire fee for the meeting room for use by the Brighton Youth Moving Forward group for the 2018/19 and 2019/20 financial years for their strategic planning purposes.
