

# BRIGHTON COUNCIL COMMUNITY CONSULTATION DRAFT MOBILE FOOD VENDOR POLICY FACT SHEET



## Permits

A Mobile Food Vendor Permit is required to operate, in addition to Mobile Food Licensing Permits, pursuant to the Food Act 2003.

Council may consider adding additional locations to those listed here, if suitable sites are identified by an applicant or the public.

## Proposed Locations

- Cris Fitzpatrick Park, Gagebrook
- Lennox Park, Old Beach
- Seymour Street Car Park, Brighton
- Pontville Park, Brighton
- 2A Eddington Street, Bridgewater
- Brighton Army Camp, 241 Brighton Road, Brighton
- Cnr Back Tea Tree Road and Rutherford Drive
- Brighton Council Chambers Car Park – Brighton and Old Beach
- Brighton Civic Centre Car Park

## Conditions on Trading

- No more than three (3) Mobile Food Vendors may operate from any one site at the same time.
- Mobile Food Vendors must only trade within any one approved trading location on not more than three days in any one calendar week and for not more than four (4) hours at a single location on any day.
- Mobile Food Vendors are prohibited from trading from any road area under the management of Council, unless specifically approved in the approved trading locations.
- Mobile Food Vendors are required to move on from a trading spot within one (1) hour of ceasing trading in any one location and are not allowed to remain parked in the same position for trade or otherwise for more than six hours.
- Mobile Food Vendors are not permitted to operate within 100 metres from an existing food and beverage business during that businesses normal trading times, unless the written permission of the business owner has been provided or within 100 metres of the boundary of a market, festival, fair or similar special event that includes food and beverage traders within the event footprint.
- A Mobile Food Vendor must ensure that parking, waste and noise does not detract or impact each location or surrounding areas and not operate within 100m of other food and drinks businesses, or special events.

## Proposed Licencing Fees

Annual - \$600  
Three Months - \$200
