Eligibility For Discounted Fee

All fees must be paid by 31st July, 2021 to be eligible for the discounted fare.

The concession rate applies to ONE dog per owner and as such a Pension Concession Card or Health Care Card MUST be sighted at the Council Office at the time of payment.

Dog Tags will be posted to owners paying in full by cheque or using the phone, internet, BPAY or Post Billpay options.
A child's pet is to be registered in the name of a parent or guardian.

Evidence of Classification

The following evidence needs to be produced prior to your dog being registered in the appropriate class.

Desexed Dog

Certificate of sterilisation from veterinary surgeon or the provision of a statutory declaration to that effect.

Pure Bred Dogs

Certificate of registration and pedigree issued by the Tasmanian Canine Association (TCA) or equivalent interstate certification, plus current membership card of TCA.

Working Dog

ABN number relating to farming business. Only applies to breeds recognised as working dogs by the Tasmanian Canine Association.

Greyhound

Registration Certificate of the Tasmanian Greyhound Racing Council.

Change of Circumstances

You must contact Council if you no longer have the dog listed i.e. death or change of ownership – Telephone 6268 7000.

Personal Information Protection Statement

The personal information that Council is collecting from you is deemed personal Information for the purposes of the *Personal Information Protection Act 2004*.

The Intended recipients of personal information collected by Brighton Council may be:

- Officers within Brighton Council;
- Data service providers engaged by Council from time to time;
- Any other agent/contractor of Brighton Council;

The supply of the information by you is voluntary. If you cannot provide or do not wish to provide the information sought, Brighton Council may be unable to process your application or request. Council is collecting this personal information from you for the purposes of managing, assessing, advising upon and determining the relevant application, or other Council related matters. Personal information will be managed in accordance with the *Personal Information Protection Act 2004* and you may make application for access or amendment to your information in writing to the Privacy Officer, Brighton Council, 1 Tivoli Road, OLD BEACH TAS 7017 or Phone 6268 7000.

NOTE: The owner of a dog that is aged over 6 months that is unregistered or not microchipped is guilty of an offence and is liable to an on the spot fine of one penalty unit per offence.

Important Information

All dogs over 6 months of age need to be registered in the appropriate class for that dog, in accordance with the Dog Control Act 2000, Section 9. The classes are:

- Entire Dog
- Desexed Dogs
- Pure Bred Dogs (Current TCA membership)
- Greyhounds
- Working Dogs
- Dangerous Dogs (declared under the Dog Control Act 2000)
- Guide Dogs and Hearing Dogs require registration but will be registered free of charge.

Evidence is to be provided for registration in some of the above classes.







Microchipping

All dogs over 6 months of age must be microchipped. Exemptions exist from compulsory microchipping for specified racing greyhounds, specified hunting dogs and all working dogs.

Maximum Number of Dogs

A maximum of two dogs can be registered at a residential property address. Three or more dogs not in a residential area will require an application for a kennel licence.
