A STATEMENT ON HOW THE BUSINESS WORKS

Although we don't train racehorses to become racehorses anymore, we are still primarily a training facility. It just looks a little different.

Our horse herd is mostly comprised of ex racehorses, ex show horses, and rescues. They are retrained to become companions/safe riding horses that can be used for anyone - including the elderly, the young, and people with disabilities. The retraining process is done by our staff as well as being built into the programs we offer.

The purpose of doing this is welfare based - too often, horses are passed around between countless owners who are not skilled enough to understand why certain behaviours are present. This almost always ends in injuries to humans and premature euthanasia for the horse. We want to train people to train horses and learn to understand them holistically.

Programs such as birthday parties were added due to public demand, and to help offset some of our running costs. We have considered becoming a club and registering under 'Sport and Rec' as your email mentioned, but this was to be eligible for community grants/sponsorships, as we find ourselves in financial hardship. We have not received any of this thus far.

Any 'community work' we do is at our own cost; we often run at a loss to provide sessions for (most recently) Chats South (lifeline organisation), women's shelters, at risk/disengaged youth, and people from low socio-economic backgrounds.

We are a small business with around 5-8 employees. We generally employ those who are not typically successful in the job market and give them an opportunity to develop important skills. Examples are young people who have dropped out of college and have no work experience skills, long term welfare recipients, and people with disabilities.

We have offered work experience to more than a dozen school aged children and we have participated in the University of Queensland Veterinary Student program – where veterinary students spend 5-10 days on site learning about managing an

equine herd and program. We do not receive any compensation for either of these things.

TRAFFIC STATEMENT


Approximately 70 cars (including staff) come in/out of the business each week. This estimate could be less in the winter months/poor weather and greater over the school holidays when we offer more programs.

We have a horse truck and run trail rides once every couple of weeks.
